YEAR 2023-2024 REQUIREMENTS TO BE FULFILLED TO OBTAIN MEMBERSHIP OF PAKISTAN POULTRY ASSOCIATION

UPDATED AS AT 28 OCTOBER 2023

- Completion and submission of Application Form. Application Form has to be signed by one proposer and one seconder too. Names of the persons who are proposer and seconder and names of their respective businesses are to be stated on the Application Form. Proposer and seconder have to be existing members of Pakistan Poultry Association.
- 2. Attaching with application form, (1) 2 Passport Size Photographs (2) 2 legible copies of NIC of Representative.
- 3. Attaching with application form, proof of filing of return of income (i.e. Income Tax return) of your business enterprise for year 2022-2023. If your business enterprise is exempt from filing of return, copy of the exemption order.
- 4. Attaching with application form, payment instrument (i.e. Cheque or Pay order) issued in favour of "Pakistan Poultry Association" and of amount according to the fee for class of membership to which your business belongs.

OTHER INFORMATION

Fee for corporate membership is PKR 16,000 (i.e. admission fee PKR 8,000 + annual subscription PKR 8,000) and for Associate membership is PKR 8,000 (i.e. admission fee PKR 4,000 + annual subscription PKR 4,000).

Corporate membership is for:

- 1. Body corporates.
- 2. Multinational corporations which have their head office or branch office in Pakistan.
- 3. Manufacturers who are registered with Federal Board of Revenue with a sales tax registration number.
- Business enterprises who are (1) registered with Federal Board of Revenue with a sales tax registration number, (2) have annual turnover of PKR 50 million or above, and (3) run business of poultry farming, manufacturing of poultry feed or other poultry related/allied products.

Associate membership is for business enterprises who:

- 1. Are not body corporates.
- 2. Are not multinational corporations which have their head office or branch office in Pakistan.
- 3. Are manufacturers who are not registered with Federal Board of Revenue with a sales tax registration number.
- 4. Are not (1) registered with Federal Board of Revenue with a sales tax registration number, (2) don't have annual turnover of PKR 50 million or above, and (3) run business of poultry farming, manufacturing of poultry feed or other poultry related/allied products.
