Agenda Points of Meeting

1. Recitation of the Holy Quran

The meeting began with the recitation of Surah Alam-Nashrah by Dr. Rana Sajjad Arshad.

2. Fatiha for Poultry Community

Fatiha was offered for all departed members of the poultry fraternity, praying for their forgiveness and higher ranks in Jannah.

3. Welcome Address by Mr. Abdul Basit, Chairman PPA

Mr. Basit welcomed all participants and appreciated Ch. Muhammad Ashraf's efforts regarding soybean import issues.

He expressed serious concern over the Rs.10 Federal Excise Duty (FED) on Day-Old Chicks, warning that this could make hatcheries economically unviable and potentially create a national meat shortage.

He briefed the house on recent discussions with Federal Minister Rana Tanveer Hussain, who acknowledged PPA's concerns.

He also highlighted a sales tax anomaly in the meat sector and emphasized the need for public awareness on poultry industry challenges.

4. Approval of Minutes – 3rd EC Meeting 2024–26

The minutes of the previous meeting (17th May 2025) were presented by Secretary General Mr. Muhammad Gul Aziz Awan.

Proposed by Mr. Malik Muhammad Sharif, seconded by Mr. Lal Bux Kolachi.

5. Discussion - Rs.10 FED on DOC

A comprehensive discussion was held on FED, sales tax complications, and industry-wide challenges:

- Dr. Sajjad Arshad requested approval to write to FPCCI and relevant Ministers regarding FED and import/export concerns.
 Chairman approved issuance of the letter.
- Mr. Ghulam Khaliq highlighted that while FED on DOC is known, the more critical issue
 is additional taxation. He shared feed mill notices and invited expert input.

Dr. F.M. Sabir

- Explained the 4% sales tax applied to unregistered persons, citing court precedents
 (e.g., ice factory case) where exempt suppliers successfully challenged the tax.
- o Encouraged members to seek legal relief when needed.
- Clarified that the Association is actively pursuing the FED case and will approach courts and the Prime Minister's Office.
- Emphasized that 4% tax is more a penalty than a regular tax.

Key Clarifications on FED & Sales Tax

- Confusion exists over whether FED applies to producers or buyers.
- o Dr. Sabir clarified that sales tax is collected by the seller, but in practice costs shift across the chain.
- FED complicates cash transactions; proper documentation is necessary.
- o Payments made through banks will attract FED.
- Small farmers (especially in Sindh) are mostly unregistered and vulnerable to tax complications.

Concerns by Members

- o Members noted farmers' hesitation to enter formal taxation.
- o Past claims may be difficult to pursue; future claims need informed action.
- FED implementation has recently begun, requiring close monitoring.

6. Finalization of Next AGM (46th AGM)

Secretary General Mr. Muhammad Gul Aziz Awan proposed holding AGM on: 30 September 2025 – Islamabad Hotel, Islamabad

Approved by the House.

7. Briefing on IPEX 2025 - By Mr. Abdul Haye Mehta

- (Senior Vice Chairman) Mr. Ghulam Khaliq thanked the organizers and proposed Dr. Rana Sajjad Arshad as Chief Organizer for IPEX 2026 and second by Malik Muhammad Shareef (Vice-Chairman Punjab) and the executive committee unanimously approved Dr Sajjad Arshad Rana as Chief Organizer for IPEX 2026.
- Chairman Abdul Basit appreciated Mr. Mehta's efforts and stressed enhanced media engagement on poultry sector issues, including inviting TV channels for coverage.
- Mr. Khalil A. Sattar endorsed Mr. Mehta's reappointment as Convenor due to his dedication and experience.
- Mr. Abdul Haye Mehta thanked members and welcomed new ideas and suggestions for future expos.
- Dr. F.M. Sabir emphasized finalizing decisions during the meeting and encouraged EC members to express objections or suggestions openly. He supported Dr. Rana Sajjad Arshad's candidacy for Chief Organizer IPEX 2026, with Mr. Mehta continuing to guide as a senior member.
- Malik Muhammad Shareef (Vice Chairman North) also addressed the executive committee
 members and informed about the IPEX registration and the dates for next year IPEX. Not
 only that but he also talked about the FED, Soya bean Meal as well as other relatable issues
 of the poultry sectors.

The house acknowledged the consistent efforts of exhibition teams and encouraged continued collaboration for future IPEX events.

Chairman Abdul Basit thanked **Mr. Lal Bux Kolachi** for hospitality and all participants for their valuable contributions.

He emphasized unity and coordinated efforts to overcome the current challenges facing the poultry industry.
