ELECTION SCHEDULE OF PAKISTAN POULTRY ASSOCIATION FOR THE YEAR 2026-28 PURSUANT TO THE TRADE ORGANIZATION ACT & RULES-2013

Announcement Of Elections Schedule:

(1) The following Election Schedule of Pakistan Poultry Association was proposed by **Mr. Malik Muhammad Sharif Vice Chairman North**, seconded by **Mr. Lal bux Kolachi Vice Chairman South** and unanimously approved by the Executive Committee of PPA on **1st July, 2026 (Wednesday)** and **within two days** of its approval by the Executive Committee, the election schedule shall be:-

- (a) Displayed at notice board of head office and regional Offices of the trade organization.
- (b) Displayed at website of the trade organization; and
- (c) Submitted to the Regulator.

2nd July, 2026 (Thursday)

(2) **Within three days** of the announcement of the Election Schedule member-firms desiring to change their representative shall intimate changes regarding name of representative to the Secretary General along with necessary proof of eligibility.

4th July, 2026 (Saturday)

(3) The Secretary General of trade organization shall display, within **seven days of the announcement** of Election Schedule, the provisional list of all members eligible to vote along with their national tax number, sales-tax-registration number, if applicable, the name and national identity card number of their representative. The list shall be displayed.

- (a) At notice board of head office and regional Offices of the trade organization.
- (b) Website of the trade organization.

7th July, 2026 (Tuesday)

(4) The members who have any objection to the entries in the list of voters shall send their objections in writing to the Secretary General within **seven days of the issuance of the voters list**.

14th July, 2026 (Tuesday)

(5) The Secretary General shall, **within five days from receipt of objections** under **AOA Section 28, sub-rule (5)** intimate action on the objections or changes, if any.

18th July, 2026 (Saturday)

(6) Any person aggrieved by the decision of the Secretary General may, **within three days** of receipt of the decision, make a representation to the Election Commission which shall decide the representation **within three days**.

21st July, 2026 (Tuesday) / 23rd July, 2026(Thursday)

(7) Any person, aggrieved by the decision of the Election Commission or in case the Election Commission fails to decide the representation within the period provided in **AOA Section 28, sub-rule (6)**, may, **within three days** of decision by the Election Commission or, as the case may be, on expiry of limitation of the Election Commission under **AOA Section 28, sub-rule (7)** makes an appeal to the Regulator who shall decide the appeal **within ten days** and his decision in this regard shall be final.

27th July, 2026 (Monday) / 6th Aug, 2026 (Thursday)

(8) **Within two days** of the decision of the Regulator the final voters list shall be:-

- (a) Displayed at notice board of the head office and regional offices of the trade organization;
- (b) Displayed at website of the trade organization; and
- (c) Submitted to the Regulator.

8th Aug , 2026(Saturday)

Provided that if no appeal has been filed to the Regulator the final list of voters shall be displayed within **fifteen days** of the decision of the Election Commission under **AOA Section 28, sub-rule (6)**.

8th Aug, 2026 (Saturday)

(9) **Within four days** of display of the final list of voters, any person, who is eligible to contest elections for the vacant post, shall send his nomination, duly proposed and seconded by a duly registered voter and signed by the candidate, to the Secretary General.

13th Aug, 2026 (Thursday)

(10) **Within twenty-four hours** of receipt of nomination papers, a copy of the final list of voters shall be provided to each contesting candidate.


15th Aug, 2026 (Saturday)

(11) The nomination papers shall be scrutinized by the Election Commission and list of candidates shall be displayed **within twenty-four** hours of the last date of receipt of nomination papers.

17th Aug, 2026 (Monday)

(12) The objections, if any, to nomination of the candidates may be filed to the Election Commission **within twenty-four hours** of issuance of the list of candidates, which shall be decided by the Election Commission **within two days**.

(13) **Within two days** of the decision of the Election Commission or in case the commission fails to decide within the stipulated time provided in **AOA Section 28, sub-rule (12)**, any candidate, aggrieved by the decision of the Election Commission or, as the case may be, on expiry of limitation of the Election Commission under **AOA Section 28, sub-rule (12)**, may file an appeal to the Regulator, who shall decide it **within seven days** and his decision in this Regard shall be final.

20th Aug, 2026 (Thursday) / 26th Aug, 2026 (Wednesday)

(13) (a) Withdrawal of Nomination Papers.

26th Aug, 2026 (Wednesday)

(14) **Within two days** of the decision of the Regulator the Election Commission shall issue final list of the candidates:

27th Aug, 2026 (Thursday)

Provided that if no appeal has been made to the Regulator, **final list of the candidates** shall be issued **within eleven days** of the decision of the Election Commission under **AOA Section 28, sub-rule (12)**.

29th Aug, 2026 (Saturday)

- (Note: as per sub-rule (12) the days we count $2+7+2=11$ so the tenure of appeal is start from sub-rule (12) if between this tenure any appeal occur then we response between in 11 days)

Polling for Election of (Executive Committee Members):

(15) **Within five days** of display of final list of the candidates, the polling for election of members of executive committee shall be held.

2nd Sep, 2026 (Wednesday)

Members Executive Committee (1000 to 1500 Hours)

(16) **Within two days** of the polling as provided in **AOA Section 28, sub-rule (15)**, any person elected as member of executive committee, shall send, to the Election Commission for **election as an office bearer**, his nomination duly proposed and seconded by an elected Executive Committee's member and signed by the candidate.

3rd Sep, 2026(Thursday)

(17) The nomination papers shall be scrutinized by the Election Commission and list of candidates shall be displayed **within twenty-four hours** of the last date of receipt of nomination papers.


4th Sep, 2026 (Friday)

Polling for Election of the (Office Bearers):

(18) **Within two days** of display of final list of the candidates, the Polling for election of office bearers shall be held.

Members Executive Committee (1000 to 1500 Hours)

5th Sep, 2026 (Saturday)

Election Results:

(19) The final result of the election of members of executive committee and office-bearers shall be officially announced at Annual General Meeting of the trade organization called for this purpose **within fifteen days** of the date of polling under **AOA Section 28, sub-rule (18)** but not later than 30th day of September, 2026.

(20) The announcement of Election Results in the Annual General Meeting under **Section 28, sub-rule (17)** shall be before 30th day of September, 2026 as per paragraph (iii) of clause (f) of sub-section (3) of section 14 of the Act.

(21) Announcement Of Election Result:

The final election results announced in the Annual General Meeting shall be:-


- (a) Displayed at notice board of the head office and regional offices of the trade Organization within two days;
19th September, 2026 (Saturday)
- (b) Displayed at website of the trade organization within two days; and
19th September, 2026 (Saturday)
- (c) Submitted to the Regulator within seven days.
30th September, 2026 (Wednesday)

Election Procedure:

The election of the trade organization shall be conducted according to the procedure laid down in the respective articles of association subject to the following: -

- (a) The election of the members of executive committee and office bearers shall be held by secret ballot;
- (b) Neither postal ballot nor proxy shall be allowed; and
- (c) The polling shall be held simultaneously at the **Head Office, Regional Offices or**, where the number of voters exceeds fifty, at the branch offices of the trade organization.

Provided that where for want of space in the office premises it is not possible to establish the polling booths, the polling shall be held in a **public place such as a community hall or hotel.**
